MAT ABACUS will not store your course material beyond 15th December, 2023 and if you fail to collect any material by this date you will lose eligibility to it - please collect your entitlement promptly.

NOTE: When you sign the enrollment form to study CPA(U) courses at MAT ABACUS, you explicitly agree to the terms of this fee schedule. Please make sure you have read and understood the contents thoroughly before enrolling.

*WEEKDAY/EVENING CLASSES. MAT ABACUS offers weekday/evening program for our popular Paper 1,3, 8 and 10 classes. Please ask at MAT ABACUS reception for details and terms and conditions.

ENROLLMENT -TUITION COURSES: For a student to be enrolled for tuition courses, the enrollment form must be completed and accompanied with your ICPAU identification card, along with full fees or a minimum deposit of Shs150,000/= per course. Students will not be enrolled unless these minimum fees are paid and will not receive any course material until full fees are paid. Any student who has not paid the minimum deposits for all enrollments by the third class of the course for any paper, will not be allowed to enter class for any paper.

NOTE: 1 PAYMENT OF FEES: Once enrolled, students are obliged to pay the balance of any outstanding fees not later than 1st September, 2023. Any student with any fees outstanding (in all papers) after this date will be refused entry to any class and use of other MAT ABACUS facilities, and will need to make a special arrangement with the administration to continue studying.

OUTSTANDING BALANCES: No new enrollment into a course will be accepted if there are any outstanding balances from previously enrolled courses. NB. There are no discounts for students with outstanding fees.

Sponsored students: Sponsored students will not be enrolled without either the minimum deposit or an accepted letter of sponsorship. Students who pay for themselves and are subsequently sponsored will obtain a full refund of their own payment.

MAT ABACUS DISCOUNT TERMS AND CONDITIONS OF ENROLLMENT

DISCOUNT APPLICATIONS NB: to be eligible for a repeat paper discount you must have attended over 80% of the classes you were enrolled for and also have submitted a script for every practice test set for your class.

<u>REPEAT PAPER DISCOUNTS</u> MAT ABACUS provides a very high standard of tuition, and MAT ABACUS students have exceptionally high pass rates. Nevertheless, MAT ABACUS cannot guarantee that all students will pass all papers. To underwrite the quality of the tuition provided, MAT ABACUS offers a discount scheme for students who having studied with MAT ABACUS, need to re-sit. For approved applications, students will enjoy a discount of Shs50,000/= per course for tuition fees.

This repeat paper discount is **ONLY** availed for the same courses(s) you registered and **paid for at the last semester**. If you only enrolled for revision, the discount is not applicable. **NB Students who are allowed a repeat paper discount**, will only be issued with new study texts if the version has changed since the previous sitting.

EXAMINATION FEES. Your tuition and revision fees are for classes only. Your full examination fees must be submitted to ICPAU by the deadline(s) set by the ICPAU. We strongly encourage early registration and payment to ICPAU.

MAT ABACUS has no authority over examination registrations and deadlines, and cannot accept any responsibility if a student fails to register with, or pay to ICPAU in time. ADMITTANCE TO CLASS: Students will be required to show their duplicate enrollment form and proof of identity to enter the class or use other college facilities, and are therefore instructed to carry both the duplicate enrollment form and their ICPAU student identity card when in the college to minimize inconvenience. Students who do not have an ICPAU student identity card should make an appointment with the administration to arrange an alternative means of identification.

Without this duplicate enrollment form and an accepted ID you may be refused admittance to class or use of MAT ABACUS facilities. An enrollment for an ICPAU course for this diet, entitles the student to access to facilities from the date of enrollment up to and including 15th Dec, 2023 ONLY.

<u>RECEIPT AND VERIFICATION</u>: Students must ensure that receipts are given for any payments made and must carry their receipts whenever they are at the MAT ABACUS, as they may be asked to produce them to obtain admittance to the classes.

Retrospective applications (i.e., after these times) will strictly be rejected. NB. A course may only be deferred once, and then only to the next semester **for the same**.
